Budget/Audit Committee met at 12:30 PM. Auditor Wallace Rowe gave an indepth report of the 2015-16 audit. It was a clean audit, there were no findings.

5. Executive Director Report

A. Administration

Todd Crabtree presented his report as written. Todd did a presentation in Fort Bragg regarding creating a homeless action plan. They want the plan to emulate the Housing First Program. This program focuses on getting people housed first and then deal with other problems the individual may have. The problem with this in Mendocino County is the lack of housing. In order for the Housing First Program to succeed, there needs to be designated places to house these people. The program is more successful in larger cities.

Todd also spoke on the radio for Jefferson NPR, out of Oregon, regarding a study of the whole United States on how difficult it is to afford to rent a home. California came in second in the nation on hardest to rent. On average, a person must make around thirty dollars an hour to be able to afford a two bedroom house.

Todd gave the Board an update on the lawsuit of the tenant at Baechtel Creek Village against the neighboring shopping center. CDC is trying not to get involved in the lawsuit.

B. Accounting

Lisa Pope presented her report as written. She had a correction to the percentage PERS cost for payroll. The unfunded liability is still increasing every year.

The new accountant that was just hired was offered another job and has resigned.

Lisa has interviewed one person for the open accountant position.

C. Development and Sustainability

Todd Crabtree updated the Board. Todd is still working on running the maintenance and energy department. He is waiting on the Federal budget before hiring a new manager.

The First Time Homebuyer program has some movement in the County.

Rural Communities Housing Development Corporation had a program, Lakewood Homes, self-help housing. CDC was given the responsibility to be the successor agency for the County Redevelopment Housing program. When RCHDC completes a phase of the project, CDC removes the restrictions on the property so that it can be turned over to the home owner. This was the last of the redevelopment funds.

D. Housing

Heather Blough presented her report as written. The vacancy rate for the PBV units is at 97%. This is due to a vacant four bedroom unit in Fort Bragg. We are having a hard time finding families large enough to fill this unit.
